By virtue of the Securities and Futures Ordinance (the " SFO "), each of AAI, GT Winners, Mr. Pang Yat Ting, Dominic and Madam Li Wai Hang, Christina was deemed to be interested in the 519,649,500 Shares held by Chun Wo Overseas.
	Note 2: R5A Group Limited is the registered owner of 80,000,000 Shares, representing 10.00% of the Company's issued share capital. It is ultimately owned as to 55.34% by Ms. Tam Mo Kit, 16.40% by Mr. Sung Alfred Lee Ming, 14.07% by Mr. Ho Chu Ming, 12.91% by Mr. Tang Kong Fuk and 1.28% by Mr. Ho Tik Wai. Therefore, Ms. Tam Mo Kit is deemed to be interested in all the shares held by R5A Group Limited for the purposes of the SFO.
	Note 3: Mr. Ng Fuk Wah is the spouse of Ms. Tam Mo Kit. Under the SFO, Mr. Ng Fuk Wah is deemed to be interested in the same number of shares in which Ms. Tam Mo Kit is interested.
